

Terms and Condition of Temporary baggage storage, delivery

This policy stipulates the rules regarding the "Temporary Baggage Storage Service" (hereinafter referred to as "temporary storage") of Okinawa Porter Service Co., Ltd. (hereinafter referred to as "the Company"). Please note that if you do not agree to these terms, you will not be able to use temporary storage.

【1. What can not be deposited】

1. Valuables (cash, passport, cash card, prepaid card, credit card, securities, gems, precious metals, prints, antiques, works of art, documents containing personal information and confidential information, etc., customers themselves valuable Refers to things that are judged to be
2. Refrigerated, frozen food
3. Animals
4. Bodies, remains
5. Hazardous substances such as volatile or toxic substances or explosives
6. Those that emit odors, those that are filthy, those that are prone to decay or deterioration
7. Unlawful goods such as stolen goods, guns and swords, and those used or threatened with crimes
8. Others judged by our staff as unsuitable for storage

【2. usage fee 】

¥ 500 up to 6 hours

¥ 100 per hour thereafter

Up to closing ¥ 1000

【3. Inspection of deposit items】

If the Company deems it necessary for deposit, we will confirm the goods (including the contents) with the consent of the customer. In addition, if we believe that the articles specified in "1. Items that can not be deposited" are contained during our storage, if there is any other reason that we consider reasonable, we will Please be aware that this may also be done by opening / checking the deposit items without obtaining consent.

【4. Usage time】

It will be from 8 o'clock to 20 o'clock on the day. It is not possible to deposit or pick up outside of use hours.

If the usage time has passed, an additional daily fee will be charged.

【5. When there is no dealings of goods to be deposited】

After 15 days, including the date of keep, it is considered that the customer has relinquished the ownership of the deposit, and we will dispose of it and the price will be used for the storage fee.

【6. Disclaimer】

In the following cases, we do not take any responsibility even if damage such as loss or damage is caused to the deposited goods.

1. When the customer deposits the items listed in “1.
2. In case of force majeure such as natural disaster
3. If the relevant public authorities are required to seize goods or submit them as evidences by the activation of judicial power, etc.
4. In the case of third party acts
5. Other cases where we do not return to our blame

【7. Our responsibility】

In the case of temporary storage, we will pay a maximum of 30,000 yen per piece of luggage, and for damage caused by an accident at the time of delivery, we will pay maximum 300,000 yen per piece of golf bag.

We will pay maximum 150,000 yen per piece of other luggage.

However, damages that are not caused unintentionally and damage that does not interfere with the original function are exempted.

(According to **【Accident Insurance】**)

【8. User liability for damage】

If the Company or a third party suffers damage by the customer's intention or negligence, or by the customer's non-compliance with the Terms and Conditions, the customer will be liable for the damage.

【9. Handling of personal information】

We will not use personal information acquired from customers for temporary storage except for temporary storage.

【10. Modification of these terms and conditions】

These terms and conditions can be changed without notice to the customer at the discretion of the Company.
